
Navigator Grants Awarded

Last Thursday the federal Department of Health and Human Services (HHS) <u>awarded 120 grants totaling \$67</u> <u>million</u> to over 100 organizations poised to operate navigator programs across the country. The <u>Utah Health</u> <u>Policy Project (UHPP)</u>, and its lead partners—the <u>Association for Utah Community Health</u> (AUCH) and <u>United Way 2-1-1</u>—were selected as the nonprofit, community-based navigator in Utah with an award of <u>\$406,788</u>.
