#### **MEDICAID REFORM**

**REVISED WAIVER SIGN-ON LETTER OPEN FOR ENDORSEMENTS, POST INPUT FROM PROVIDER GROUPS**

Following last week's invitation to endorse a sign-on letter to CMS with recommendations for Utah's Medicaid ACO waiver, we received several requests for additions or changes to the letter—a few from key provider groups. We found most of these changes so worthwhile that we would actually like to circulate [a revised letter](#) and re-start the sign-on campaign.

To summarize the changes:

- They give the letter a softer, more conciliatory tone, but without minimizing the concerns raised in the original. This will help us have a seat at the waiver negotiation table.
- CMS has had 4 phone meetings with the state: while CMS officials share many of our concerns related to cost sharing and benefit standards, they are sympathetic to the overall direction and intent of the waiver and ACO proposal. Against this background, we think we will do best to focus on improving the waiver in the concrete ways outlined in the revised letter—and not rejecting the waiver outright.

#### **ACCOUNTABLE CARE INTENSIVE WORKSHOP A SUCCESS...DETAILS TO FOLLOW**

A week ago UHPP and the Medicaid Reform Leadership Team hosted an intensive workshop on accountable care ([ACOs](#) are groups of health care providers who agree to be held accountable for improving health care quality while lowering costs). featuring local and national experts on accountable care. The purpose of the workshop was to strategize (via common vocabulary, shared concepts, lessons from Utah and elsewhere) how to pivot from the waiver to a meaningful transition to accountable care & payment/delivery system reform. On our [Medicaid Reform Central](#) webpage we've posted [highlights](#) and [additional resources](#) from this important event. In the meantime, please enjoy the resource kit and speaker biographies from this session. At the session we heard good news from the new Medical Director for Utah Medicaid, Dr. Joseph Cramer: CMS has rejected the waiver's proposal to increase cost sharing for children and pregnant women! This part of the proposal is off the table. Of course, this could leave other Medicaid groups like people with disabilities, parents, and low-income parents even more vulnerable to higher cost sharing obligations. This means we will need to be vigilant and fully engaged in the waiver negotiation process—*see above, Revised Waiver Sign-On Letter*.

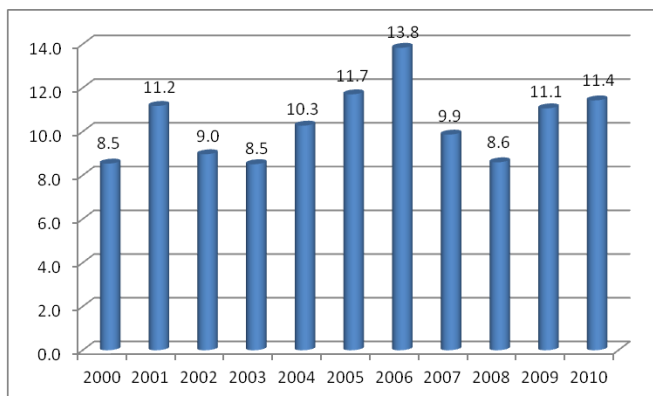

#### **NUMBER OF UNINSURED AMERICANS & UTAHNS CONTINUE TO RISE, US CENSUS BUREAU SHOWS**

More Americans did not have any sort of health insurance coverage in 2010 (49.9 million) compared to 2009 (49 million) according to the US Census Bureau report “Income, Poverty, and Health Insurance Coverage in the United States: 2010” released last week. Over the same period the number of Utahns without health insurance increased slightly, from 11.1% in 2009 to 11.4% in 2010—despite the fact that the state is entering year 4 of state health reform.

#### **THE AFFORDABLE CARE ACT: HOW ARE IMMIGRANTS IN UTAH IMPACTED? [New UHPP brief!](#)**

The health care and insurance changes in the ACA will impact all categories of immigrants—naturalized citizens, legal immigrants, undocumented immigrants, and refugees—and their children. The new consumer protections and opportunities for access to health care for immigrants go a long way in ensuring they have access to the health care they need. However, the law does not

eliminate the Medicaid 5-year waiting period for immigrants with undocumented status, making our safety net health care providers, like Community Health Centers vital. In addition, plain language materials and language and culturally competent consumer assistance will be necessary for immigrants of all statuses when navigating the new health insurance exchanges and premium tax credits (subsidies), and applying for coverage through public programs (like Medicaid and CHIP).

### **CONSUMER PROTECTION IN RATE REVIEW: INSTALLMENT #3 OF OUR COST CONTAINMENT SERIES**

*New UHPP Fact Sheet!*

Hot off the press, UHPP just published a [new fact sheet about Insurance Premium Rate Review](#). Beginning this month (September 1, 2011) insurance companies must publish and justify all proposed premium hikes of 10% or more for the individual and small group markets, and state insurance departments must review them. This is part of the nation's health law as established by the Affordable Care Act (ACA). In order for rate review to help consumers, Utah's Department of Insurance (DOI) needs both the authority and resources to do so. HB128 (Rep. Dunnigan) gives our insurance department the responsibility to review rates but not the authority to do anything about non-compliant insurers. Utah accepted a \$1 million [federal grant](#) last year to prepare for this new task and now have the staff needed to review 100% of all rate filings.

There's a lot of work to yet be done to build strong consumer protection into Utah's rate review process: Utah's rate review process must be transparent, include a forum for public comment, and grant Utah's DOI authority to enforce its decisions.
