1. **Where we stand on Health & Human Needs...in light of new revenue projections**

The revised FY 2008 revenue projections were released on Tuesday (General Fund is up by \$49 million, of which \$24 million is true surplus). Right now, it seems as though there is a desire among House Republicans to use most, if not all, of the new ongoing surplus to increase the proposed tax cut to somewhere between \$208-245 million. Meanwhile, Senate Republicans and Governor Huntsman are standing by their commitment to a \$150 million tax cut. There also appears to be little appetite to dedicate the increase in ongoing money to long-term needs (like dental and vision services and CHIP) because of the unpredictable nature of the revenue sources. Add to that the amount still to be divvied up between roads and buildings and it becomes clear that unless the parties can reach a reasonable compromise on the amount of the tax cut, **all non-**

mandatory Health and Human Services priorities are in serious jeopardy at this time.

On Wednesday the Executive Appropriations Committee met to accept the base budget and the revenue projections and approve the intent language recommended by the sub-appropriations committees. Unfortunately, the committee did not approve the language adopted by the Health and Human Services Appropriations Committee directing any savings derived from the preferred drug list to dental and physician reimbursement rates. However, several committee members expressed support for the concept, and it appears to be a matter of finding the correct vehicle. As you speak with members of Executive Appropriations and your own legislators, please emphasize how important it is that Medicaid be allowed to re-invest the savings from the PDL and the change in the federal matching rate to restore services and improve the quality and timeliness of care.

- mental health funding.

3. FEDERAL FRONT: Next Steps for SCHIP Reauthorization

In 2007, Congress has an incredible opportunity to provide health insurance coverage to more kids. Reauthorization of the Children's Health Insurance Plan (CHIP) will help America's kids' health and their ability to succeed in life. However, Congress must make reauthorization a top priority and allocate enough funding to build on the remarkable success of the program.

The new Democratic-controlled Congress has brought along with it many changes to the rules under which Congress operates. In an effort to encourage fiscal responsibility in the budget process, legislators have introduced the "pay as you go" or "pay-go" rule. Simply put, the pay-go rule says if Congress wants to increase spending on entitlement programs or cut taxes, it must pay for such changes with cuts or tax increases elsewhere in the budget.

Some believe that this rule could negatively affect the reauthorization. However, pay-go does not

preclude a good CHIP reauthorization bill. Congress can find the much needed increase in funding for CHIP by closing tax loopholes or cuts in less important federal programs. So long as advocates are diligent in reminding Congress how important CHIP is to America's children and youth, funding can be found to substantially increase CHIP funding and ensure more children have the health insurance that they need.
