Follow-up	<p>Last month UMP decided to put on three summits in the fall on Medicaid issues (Medicaid and Health Reform; Long-term care and Medicaid; Cost Containment/Revenue Enhancement in Medicaid).</p> <p>There are two events that we may now want to try to combine with:</p> <ol style="list-style-type: none"> <li>1. Families USA visit--August</li> <li>2. UHPP/Community Catalyst Implementation Conference--October 28<sup>th</sup></li> </ol>	<p>The group decided that pairing UMP's summits with Families and the Community Catalyst events make sense.</p> <p>The group was interested in what speakers were coming from Community Catalyst and what their expertise is. Lincoln said he would bring information about the speakers to the August meeting.</p>
Families USA Visit.	<p>On August 16-17, Families USA will be coming to Utah.</p> <ul style="list-style-type: none"> <li>- What do people want to discuss?</li> <li>- Who do we want to invite?</li> <li>- Combine summit with visit?</li> </ul>	<p>The group decided on three different topics that they would like Families to help with.</p> <ol style="list-style-type: none"> <li>1. Cost-containment within Medicaid. The group thought this meeting should be in the morning before interim so we could attract the maximum number of legislators.</li> <li>2. Medicaid Payment Reform: that this meeting should focus on payment reform mythologies like accountable care organizations. This meeting's audience should be advocates and key policy leaders like Sen. Liljenquist.</li> <li>3. General Medicaid and health reform meeting geared for a broad audience of consumers, advocates, and policy leaders.</li> </ol>
