In 2019, UHPP adjusted its business model to better sustain its commitment to assisting vulnerable Utahns with access to health care and health insurance. UHPP staff became licensed as health insurance producers in the state of Utah, earning commissions paid directly to UHPP and invested back into the UHPP's mission. In 2019, UHPP also contracted with outside organizations to "conduct coverage to care" and health insurance outreach and enrollment. UHPP was reimbursed by outside organizations for conducting this work.

Take Care Utah

UHPP's Take Care Utah (TCU) program was launched in 2010 as a community-based health insurance assistance program. It has since expanded significantly and serves primarily low-income and underserved Utahns of disparate backgrounds, including but not limited to individuals who are refugees, Hispanic, homeless, LGBTQ, or who struggle with substance abuse disorders. UHPP manages 20 Health Access Assistants directly and provides training, support, and an online lookup tool to 60 assistants managed by other organizations across the state. No matter where an individual resides in Utah, there is an assistant nearby who will provide fair, accurate, and impartial services. In 2019, TCU Health Access Assistants (HAAs) helped 583 people apply for health insurance through the Federal marketplace and 4,516 people apply for coverage through Medicaid programs. TCU HAAs also reached

over 13,138 people through phone calls, presentations, media events, and outreach events.
